

## Trustd.ai's Terms of Use

These Terms of Use ("Terms" or "Agreement") govern your rights and obligations regarding the use of Trustd.ai services and sites, which is owned by Sovrign Inc., a New Jersey company (collectively referred to as the "Service" or "Site" or "Trustd.ai") on the Internet.
